**COPYRIGHT TRANSMITTAL AND AUTHOR DISCLOSURE CONSENT**

To the Editorial Board of *The Journal of the Oklahoma State Medical Association*

This Agreement is made and entered into as of this \_\_\_\_ day of \_\_\_\_\_ by and between the undersigned "Author," whether one or more and the Oklahoma State Medical Association, an Oklahoma not-for-profit association known as "OSMA."

WHEREAS, the OSMA maintains and publishes a journal (the "Journal") containing approved written submissions ("creative works") from authors and

WHEREAS, the OSMA requires that in order for OSMA to review, edit and/or publish a creative work from the Author, Author agrees to transfer the creative works pursuant to the terms of this Copyright Transmittal & Author Disclosure Consent (the "Transmittal") as hereinafter provided:

NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:

1. For the purpose of evaluating the creative works, Author hereby assigns, transfers and conveys to OSMA, all of Author's right, title and interest in the creative work, as described herein, including but not limited to any and all copyright or ownership rights.
2. If and to the extent that OSMA does not publish the creative works, OSMA shall return the creative work to Author and this Agreement shall have no further affect.
3. If and to the extent that the Author or any "Owner" provides any "Supporting Information" to OSMA, the Owner is granted a perpetual non-exclusive right to publish, re-publish, transmit, sell, distribute or otherwise use the Supporting Information, in whole or in part, in electronic and/or print editions of the Journal.
4. Any reproduction, posting, transmission or distribution of the creative works as finally published by OSMA, shall require, a citation to the Journal, suitable in form and content to include the following: (i) Title of Article; (ii) Contributor/Author; (iii) Journal Title and Volume/Issue; (iv) Copyright © year; (v) Copyright owner as specified in the Journal and (vi) Publisher.
5. The Author will report to OSMA any financial interest/arrangement or affiliation with any organization offering financial support, gift or grant monies. Exhibit "A" attached hereto contains any required disclosure of any financial interest/arrangement or affiliation.
6. The Author will report to OSMA any significant relationship, with any person, firm or entity, as it relates to any commercial product(s) discussed in the creative work, or any conflicts of interest relating to the creative works. Exhibit "A" attached hereto contains any required disclosure of financial activities or conflicts of interest. (Note: Any disclosure as shown on

Exhibit "A" will not prevent publication, unless in the sole discretion of OSMA, such disclosure will not be in the best interests of OSMA.

7. Author will not disclose or discuss any unlabeled use of a commercial product aspect of the creative works or Supporting Information, unless lack of FDA approval is clearly stated in the creative works or a release is first obtained.

8. Author represents to OSMA that:

a. Author hereby gives OSMA permission to use, without permission first obtained, any photographs contained in the creative work.

b. That the creative work is not currently under consideration for publication or previously published in another journal or medium.

c. That Author (s) have had a material participation in data collection, analysis, interpretation or writing of the creative work.
